## Treasurers Report

End of Second Quarter 2015

The current balance in the PNC checking account is $\mathbf{\$ 3 2 1 . 3 6}$ and the PayPal balance is \$241.96. There has been very little financial activity this quarter other than tax payments to the Commonwealth of Virginia (where MARTC is registered as an LLC) in the amount of $\$ 51.63$, to the I.R.S. in the amount of $\mathbf{\$ 1 2 9 . 0 8}$, and a $\$ 400.00$ payment to the I.R.S. to file our application for 501c3 status. We are also currently paying a $\$ 12.00$ per month service charge to the PNC Bank. At the time that MARTC achieves 501c3 status ALL of those payments will go away - no more tax payments and no more bank service charges. So, along with the ability to accept tax-deductible donations there are obvious reasons for why the 501c3 will benefit the Club.

As far as the current status of the 501c3 application, the Club received a request for additional information related to the specific language in our organizational documents. The Board will be addressing these issues and amending organizational documents to include the necessary language required by the I.R.S. as we work toward the goal of achieving 501c3 status.

## The Story of Dhys

Hardiness, resilience, and stubborn determination in the face of adversity are all trademarks of the Rat Terrier. Rhys is a prime example of those qualities in action. In the spring of 2012, at just two years of age, he was injured in an accident that left him completely paralyzed. He had no deep pain sensation, which meant he was not a good candidate for back surgery to repair his ruptured disc. The odds of making a complete recovery were less than one in one hundred.

Our options were limited - we could either try conservative treatment with medications and wait to see if he would recover, or we could euthanize him. It took a lot of soul-searching for me to decide what would be the best and kindest course of action for him. in the end I decided to let him choose his fate. As long as he was willing to fight I was willing to stand by him. Rhys had no idea the odds were against him. It's one of the perks of being a dog.

our lives were drastically altered. His activities were limited because he could no longer run or jump. He could not control his bladder or bowels and needed to wear diapers and be manually expressed several times a day. For several months he had to be walked with a sling made from an old bed sheet until I could save money to have a wheelchair custom built for him. I constantly questioned whether or not I had made the right choice, if he could still have a quality life with his disability. Surviving is not the same as thriving and merely being alive was not enough.

I was worried that he would not like the wheels and might find them scary or annoying, but he took to the cart like he had been using it his whole life. I saw him run for the first time in eight months and I bawled. The doubts that I had carried with me about whether or not I made the right decision to save him were gone. Life was good again.

Apríl marked three years since he became paralyzed. He never did make a full recovery, but he did regain a bit of function in his legs and is able to wobble a little bit. Every day is a blessing and I have committed myself to making sure that his life is as fulfilled and happy as it can possibly be. We go on adventures - hiking, camping, swimming, chasing, fetching, playing, you name it. There is not much that he cannot do, even if i try to discourage him because it is unsafe. If he's determined to do something he'll do it. Typical terrier.


The thing about dogs is that they adjust much better to changes than people do. Rhys knows that he's different and that his body is compromised. He just doesn't care. It's the way things are now and there's no use wallowing in sadness and regret. My time with Rhys has taught me more about life than anything I've ever experienced. I don't know how long our journey will be or where it will take us, but I am happy to take it with him. One wobbly step at a time.

## Smell This!

Dogs smell things. A lot of things. A lot of the time. Their noses are very important to them.

And, most dog folks would agree that the dog's nose is a pretty amazing sense organ. Indeed, we capitalize on our dogs' olfactory (smellin') acuity when we train them to select scent articles in Utility training, follow a missing person's trail, find contraband and other nasty stuff in public places, and even detect the presence of cancer in human patients. Research in recent years has shown us that the dog's impressive smelling abilities are due to a number of pretty cool physical adaptations:

1. LOTS OF CELLS: Dogs have hundreds of millions of olfactory receptor cells lining the inside of their nose; many times more than the number found in the human nose. This difference contributes to their ability to detect almost impossibly minute concentrations of compounds. This large number of canine olfactory cells is enough to cause smell envy in any dull-nosed human.
2. BIG BRAIN: Two parts of the dog's brain that interpret incoming information from the nose are the olfactory bulb and the olfactory cortex. Both of these areas are highly developed in dogs and are important for how dogs use the sensory information that the nose provides.
3. SNIFF SNIFF: Dogs sniff. We don't. Sniffing involves a disruption of the dog's normal breathing pattern and functions to enhance a dog's ability to detect and differentiate smells. Here is what we currently understand about sniffing: First, as the dog inhales during a sniff, the air is diverted into several flow paths. This partitioning effectively increases the number of sensory cells within the nose that inhaled components are exposed to, increasing olfactory sensitivity. Then, during the exhale phase of the sniff, the air leaves via the dog's "side-nostrils", not out the front of the nose as it does with normal breathing. (So that's what those slits in the side of my dog's nose are for! Who knew? :)). Exhaling through the "side nose" is presumed to prevent the dog's sensory cells from being repeatedly exposed to the same compounds, thus slowing the process of scent habituation. (Consider how you no longer can smell "wet dog" after being around it for a while; that's scent habituation).

Choice by Smell: Recently, researchers at Barnard College's Dog Cognition Lab asked a broad question about the dog's olfactory ability: "How do pet dogs use their nose to make decisions and choices in their every day lives?". Alexandra Horowitz, Julie Hecht and Alexandra Dedrick began this series of studies by first asking if dogs have the ability to discriminate between large and small concentrations of smells (1). This question was of interest because previous work has shown that, similar to many primate species, dogs can visually discriminate between different quantities of food (2). It follows that, since the dog's nose is so spectacularly talented, that they would be at least equally capable of the same type of choice using their noses. Here is a summary of their recently published study:

Study Design: A group of 69 pet dogs (and their people) were recruited for the study. Following some initial pre-training, dogs were presented with two covered plates, equidistant apart. One plate held a single chunk of hotdog. The second, the motherload plate, held five chunks of hotdog. In the first trial, dogs were given no guidance at all from their owner and were allowed to choose one of the two plates. In a second trial, designed to test for the effects of social cues, the owner showed a clear preference for the plate holding the single piece of food before their dog was allowed to make his or her selection. (These procedures were quite involved and are described in detail in the paper).

Results: There are actually a number of interesting findings (and additional questions) reported in this paper. For brevity, I will focus on two that I found to be especially relevant:

1. First: The dogs in this study, who were pet dogs that had no previous training in any type of scent detection or scent following work, did not demonstrate an ability to discriminate a "small quantity" from a "large quantity" of food using only their sense of smell. This result is surprising, since dogs do seem to have this ability when tested using vision and considering what we know about dogs' highly developed olfactory acuity.
2. Second: When dogs' owners showed a clear preference for the plate that held the smaller quantity of food, the dogs did show a significant preference - for the plate with the smaller quantity! In other words, dogs were readily and easily influenced by the social cues provided by their owners regarding which plate to choose. This result was in agreement with the visual preference study - dogs of owners who pointed at a plate that clearly contained the smaller pile of food were more likely to choose that plate over the plate whose food runneth over!

Conclusions: The authors of this study suggest that our dogs, living in a human-centered environment, may not always be using their noses to the extent of their actual ability. Perhaps when making decisions in everyday life dogs learn to depend too heavily upon social cues from their human companions, to the extent that they ignore information from their own senses.

Take Away for Dog Folks: The results from this study led me to think about how we live with our dogs and how we may unwittingly discourage them from using their noses on a daily basis. Maybe, by caring for our dogs so well, and making so many of their decisions for them (what to eat, when to eat, how much to eat, what plate to choose), we influence a bit too much and unintentionally inhibit one of their most amazing and enviable talents. For example, at my training school we teach "Leave $i t$ ", a command that can keep dogs safe when they decide to investigate something that may be dangerous to them. However, when we ask for this behavior, are we unintentionally inhibiting dogs' use of (and enjoyment of) their nose? Just a thought. Personally, I still will always teach this response to my dogs (and those of my students) because it is truly an invaluable behavior to train for its safety and control utility. However, reading this study has encouraged me to consider a bit more carefully each of the everyday circumstances in which I use it.

Consider also the currently popular K-9 Nose Work classes. Almost uniformly, reports about these scent work games are that dogs, (all dogs, regardless of their level of previous training, age, or athletic ability) LOVE, LOVE, LOVE K-9 Nose Work and the success that they experience when encouraged to use their nose and search independently. Perhaps these classes are unleashing some of that latent "nose power" that all dogs have and that they may not always be encouraged to use when living in a typical anthropogenic (human-centered) world. So, Kudos to all of you who encourage your dogs to smell, sniff, find (safe) stuff, and who play nose games with your dogs, teach them to track, or simply regularly encourage them to "SMELL THIS!"

# Collar or harness, what to choose? 

## What is a balance trainer?

As a dog trainer and behaviourist I read a lot, watch different TV shows, and try to get informed on new technics and trends in the field of dog training.

One of the most important changes in the last 20 years was to go from an exclusively dominant type of training, to a softer and sometimes even non-verbal training (clicker). Unfortunately with changes come all the politic. Now we reached a point where people are humanizing their pets so much that there is no respect of their natural individuality. I am the first one to talk to my dogs and use silly names for them and treat them like part of the family. This being said I do also understand that they are not human and will never be. They cannot understand all I am saying, they love the attention and would respond with funny faces or even by smiling. Yes dogs do smile, not all of them but some do and it is a real treat to see one smiling of joy.

My point today is to put things into perspective. Evolution is a natural process, humans evolve around the landscape that surrounds them and animals do the same. When the city invade their territory they will adapt and learn to live a different way. This does not mean that they loose completely their nature; they just take advantage of, or suffer from the new situation.

We know that humans from the 12th century were not the same as we are now, but the fundamentals of what make mankind human stayed the same. We still live in a way where we have leaders and followers; we still have rich people and poor people. We still have people that envy others, we still love and hate, and we are supposed to be the most evolved of all animals. So based on this why less evolved being would change so drastically that all the natural instincts will disappear in just a few years?

What I am getting at; is that believing that dogs are now so tame and dependent to us that they will never return to their natural instinct is ludicrous and dangerous. I do not pretend to be a scientist and to know everything there is to know about dogs and pets in general, but I spent the last 50 years studying horses, dogs and cats behaviour. All three animals are different in shape and in nature. And if you take any of these animals away from their life with humans, they will return to their basic instincts in no time.

A lot of our city dogs are coming from specific breeding and because it makes life easier a lot of backyard breeders would use a tame animal that will breed another tame one, resulting in a doubling up good temperament. I am talking about backyard breeders, as most of the pet population today is still coming from no paper or crossbreed. The purebred with showing background is a smallest part of the pet population. Do not take me wrong, I do not say that backyard breeders are bad, but they first of all are looking to make a little money without having to do much. But this is not the point right now anyway.

So with a population of very tame dogs, why do we get dogs that are unruly, barks and lunge at everything that is moving? Often it is due to a lack of socialization at a young age, but more and more I see dogs in my business that are not exercised enough, that have been through training classes with flying colours and suddenly are showing unwanted behaviours. Maybe we should ask ourselves why? We take for granted that once the classes are finished the dog is done learning and does not need to be remind what are the rules. Most of our pets go to puppy classes and sometimes even to obedience training 1 and 2 and by the time they are 12-14 months or younger the all process is done and dealt with.

At that time they are just coming to teen age and we all know what teenage time brings. It is a time when the main changes occur in our brain and body the dogs also mature at that time. Not all the rebellious teenagers become delinquents the same can be said for dogs too. The majority will mature into nice and quiet companions. But some of them will not, and here comes trouble because with the new trend in believing that dogs are not anymore driven by their pack position it can be dangerous. Dogs still have their dominant instinct, just like humans have and just like in humans not many are real leaders and most are followers, but a leader that cannot explore its true nature is frustrated and the frustration grows every day. Being a leader in dogs does not mean that the pack leader is dominant and violent. He or she is stable have no need for aggression to prove his/her position and can get respect just by changing the way he/she holds the whole body.

Body language in dogs is very important and we will discuss it another time, but look at Bailey's attitude when meeting with other dogs and watch their way of communicating. Being a leader in the wild is not just having a strong and powerful body that can protect the pack, if you look carefully you will see it is not always the case. But it is also being stable, not letting the puppies and youngsters being unruly. Being a leader is being able to find the right place to sleep, to play, to hunt or just relax in peace.

Being a leader in urban life is completely different as we assume that our dog should understand that we are the natural "boss" and they have to live by our rules, they have been raised to be followers for centuries. More and more people want to deny the fact that dogs are related to wolves, even if it has been proven genetically. And if they accept that fact reluctantly then they will argue that a wild animal has nothing to do with our domesticated dogs. The studies on which we base our knowledge of the pack environment was conducted long time ago and with wolf packs in captivity. How can that be relevant? I do agree that some of the studies were maybe not as relevant as we thought. The animals were placed together and the packs not naturally formed. Well, here you have your answer, we do impose to our dogs to live by our rules, we choose them, choose where they will be walking, where they will be sleeping and when and where they will meet other people and dogs. So at the end the studies were not as far away from reality.

But lets assume for a moment that evolution in dog behaviour was so drastic in the last 40 years that now they lost their survival instinct and with it their natural way of living. Then how do you explain that if dogs are left without humans to take care of them they return in no time to their basic instincts?

So what should be considered balance training? When we take in consideration all the needs and desires of the dogs? Or for what is convenient for us?

A balance trainer/behaviourist is someone that know when to use a stronger hand and when to reward. A balance trainer is someone that does not think that dogs are machines that will repeat the same things time after time, but believes that pets can also have a bad day. A balance trainer is someone that can recognize a leader from a follower and understand the difference between the two. A balance trainer is someone that gives a choice: do right or do wrong, and show what is expected. A balance trainer is someone that can understand the basic instinct of an animal and make it a powerful teaching tool. We have so many distinctive breeds that were created for our needs and pleasure, why not use their natural instinct to teach them how to behave at home and in the world. A dog with a huge prey drive can be tone down; you can re-focus the energy on something else that will keep it under control. You cannot just erase it from their mind by breaking the spirit of the animal. Most of our dogs want to please us, we can teach them many different things. They want to be with us, share every minute with us, which is why they accept many situations that are not always good for them. As long as you give them a little bit of love they will love you back. But they need discipline to learn how to behave around us and we need to teach them. Dogs, like kids, do not come pre-programmed on good behaviour.

But first of all a balance trainer is someone that can also read the pet's owner, that is capable to demonstrate what in the behaviour is due to lack of discipline or by lack of understanding of the specific pet's individuality. A balance trainer is someone that can repair the communication between a pet and it's owner(s). A balance trainer is someone that will use the right tool at the right moment. A balance trainer is someone that learns from the past and adapts the teaching/learning technics to the future.

## RAT TERRIER COLORS \& PATTERNS

MARTC collaborated with Dogworks to have a basic breed color chart created with hopes of helping new Rat Terrier owners and Judges correctly identify colors for the breed. With 19 colors and 9 patterns (based upon what is currently offered on AKC paperwork) it is not often easy to discern what color and pattern a Rat Terrier displays.

As a new breed with such complex colors and patterns, our club has hopes that RTCA will approve and accept this color chart. We believe it would be of great help to Judges and exhibitors. At the time of this newsletter, the club is still awaiting RTCA feedback and blessing on the chart.

In addition, another nice benefit is the club now has all the colors and patterns to create some nice items for future fund raising.

## Rat Terilier Breed Standard

## General Appearance

The Rat Terrier was originally bred for ratting and farm work. A multipurpose companion dog that is capable of hunting rodents and vermin above and below ground, and to course small game. He is a sturdy, compact, small-to-medium sized parti-colored dog giving the appearance of elegance and fitness, denoting speed, power and balance. Honorable scars or a couple of broken or missing canines or incisors teeth are not to be faulted. The following is a description of the ideal Rat Terrier. Variations are penalized to the extent of the deviation.

## Size, Proportion, Substance

Size- There are two separate size divisions. Miniature At least 10 inches, not to exceed 13 inches. Standard $\square$ over 13 inches, and up to and including 18 inches in height measured at the withers. Any dog six months of age or older measuring less than 10 inches, or any dog over 18 inches are to be disqualified.
Proportion - The Rat Terrier is just slightly longer than tall. The height, measured vertically from the ground to the highest point of the withers, is slightly less than the length, measured horizontally from the point of the shoulders to the point of the buttocks. Shortness in leg is a serious fault. Substance - Moderate bone in proportion to size. A well-balanced, hard-muscled dog with smooth lines under taut skin. This dog should not be rangy nor fine boned and toyish, and never bulky or coarse. They are shown in good, hard physical working condition.

## Head

The head resembles a smooth, blunt wedge from a front or profile view. When seen from the front, the head widens gradually towards the base of the ears in an unbroken line and is well filled up under the eyes. The expression is intelligent, alert and full of interest. The eyes are not large. They are obliquely set wide apart and are oval in shape. Eye color varies with coat color from darkest brown to hazel. Eye rim pigmentation corresponds with nose color and facial markings. Gray eyes are acceptable in blue or blue-fawn dogs only, being a serious fault in other colorations. Any blue in the eye(s) is a disqualification.

Ears- Set on the top outer edge of the skull, V-shaped, with the length in proportion to the head moderately pointed at the tip. When viewed from the side, the base of the ear is on line with the outer corner of the eye. Ears should match in shape and carriage when alert, and can be carried erect, semi-erect and tipped, or button without preference. When alert, a rose ear is a fault. Cropped ears are a disqualification.

Skull -When viewed from the front the skull is moderate in width, relatively flat on top, and rounded at crown and the sides as it widens smoothly from the corner of the eyes to the base of the ears. The occiput is not prominent. The cheeks are flat and well-muscled, but never bulging. The stop is moderate but distinct. The muzzle is strong, just slightly shorter in length than the skull and tapers smoothly along the sides to the nose. The nose color corresponds with the body color and is entirely pigmented. Flesh-colored noses are considered a fault in lemon or light apricot colorations while being a serious fault in other colorations. Seasonal fading is permitted. Thelips are clean and tight, and correspond in color with the nose leather or may be pink; either solid or spotted is acceptable. The lower jaw and teeth are strong and well developed with no sign of being snipey or weak.

Bite- A scissor bite is preferred. A level bite is acceptable.

## Neck, Topline, Body

Neck-Length of neck is in proportion to the head. Strong, arched along the crest and dry, the neck blends smoothly into the flat shoulder blades. Topline- Smooth and blending from the back through the loin and set of the tail. Body $\square$ The body is compact, strong and flexible with well sprung ribs. The brisket extends to the elbow. When viewed from the front, the ribs appear to be oval. The Rat Terrier, while muscled and fit, has flat muscles that blend into the body. The chest is moderately wide and well filled with a discernible forechest. The underline ascends gradually with the ribs extending well back to a moderate tuck-up.
Back - The back is level and firm from the withers to the loin. The short loin has a slight muscular arch blending into the gently rounded croup. Tail- The tail set is a continuation of the spine. Tails are customarily docked between the second and third joint, or can be a natural bobtail or left naturally long and tapering to the hock joint. Length is unimportant. The carriage is variable depending on attitude, carried from slightly below horizontal to almost erect, but not over the back or a ring tail.

## Forequarters

The shoulder blades are well laid back with flat muscles providing enough space between the shoulder blades to allow for free movement. The shoulder blades and the upper arms are nearly equal in length and well set back so that the elbows fall directly under the highest point of the shoulder blade. The depth of the body at the elbow is the same distance as from the elbow to the ground. The forelegs stand straight and parallel with elbows turning neither in nor out. The pasterns are slightly sloping when viewed from the side. The feet are oval in shape. The toes turn neither in nor out, are compact, moderately arched, with thick pads and strong nails. The front dewclaws may be removed.

## Hindquarters

The hindquarters are muscular but smooth and in balance with the forequarters. They should not be bulging or coarse. Stifles are well-bent with short hocks that are parallel and perpendicular to the ground. The hind feet although slightly smaller are similar to the front feet. Rear dewclaws are removed.

## Coat

Short, close lying, smooth and shiny coat. Texture varies; a very slight ruff or wave along the back is allowed, but undesirable. Any suggestion of kink or curl is cause for disqualification. Whiskers must not be removed. Absence of coat (total genetic hairlessness) is a disqualification.

## Color

Any variation of Pied patterning is acceptable. Pied is described as comparatively large patches of one or more colors in combination with white. Except for the "solid white" extreme piebald dog with only mottled/spotted skin. Disqualification - Rat Terriers are never a solid ground color without white markings, or bi-colored without one color being white. Acceptable colors with or without "tan points", include the predominate Black, or Chocolate, Red, Apricot, Blue, Fawn, Tan, Lemon, or White. Intense, dark shades of color with clearly defined and delineated coloration is preferred. White on the body is preferred to be between $10 \%$ and $90 \%$, but all Patterns; spotted, patched or splashed with white in conjunction with (or without) any combination of white on the face, head or ears are equally acceptable without prejudice. "Tan Points" are common and vary in shades of cream to rust. Badger markings are acceptable. Speckling, ticking and mottling is common, but heavy ticking is undesirable. Sabling is permitted in the coat or as shading on the head or penciling on the toes. A "black mask/black muzzle", on a dog not having black as coloration is to be seriously faulted. A few white hairs do not constitute an acceptable marking. A minimum white marking consists of a patch or strip of white with underlying white/pink skin on the forechest or body that exceeds one inch. Less than one inch of white at its widest dimension is a disqualification. Brindle or Merle color patterns are disqualifications.

## Gait

A ground-covering efficient trot with good reach and drive suggesting agility, speed and power. The legs are parallel at a trot, but as speed increases, the legs converge toward a center line. There should be no elbowing out, weaving or rolling action while in motion.

## Temperament

Keenly observant, devoted, full of energy, yet easily trained and obedient to command. The Rat Terrier is a non-sparring breed and generally friendly with other dogs, but may be reserved with strangers. Submissiveness is not a fault. Overt aggression and excessive shyness should be penalized.

## Disqualifications

Any dog over six months of age measuring less than 10 inches, or over 18 inches. Any blue color in the eye(s). Cropped ears. An absence of coat (genetic hairlessness). Any suggestion of kink or curl, or coat type other than described. Solid colorations (other than white). Bi colors without white, or dogs with a patch or strip of white measuring less than one inch at its widest dimension. Brindle or Merle color patterns.
