- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. MAJOR POINTED RAT TERRIERS: Entry of major pointed Rat Terriers will be allowed.

PROFESSIONAL HANDLERS. Are NOT permitted to show at the Sanctioned A Match.

LUNCH: Bring your own lunch and drinks as well as water for your Rat Terriers(s).

PORTABLE TOILET: The park provides a portable toilet that is handicapped accessible.

PAYMENT OF ENTRY FEES: Make checks or money orders payable to Rat Terrier Club of Montgomery County PA. No responsibility is accepted for cash sent through the mail. Entries received without fees will not be accepted. All payments must be made in US funds. Returned checks do not constitute a valid entry fee.

<u>JUDGING TIMES</u>: will be published in the Judging Program. Rat Terriers may arrive prior to their scheduled time of judging. Rat Terriers not required for further judging will be excused. The judge is not required to wait for Rat Terriers. It is the responsibility of the owner/handler to have their Rat Terriers at ringside when required and without being called via public address system or the like.
